- 1. Reference to your letter dated 27 December 2023. In the 39th Executive Council Meeting of the Association held on 11 Jan 24 at 1630h. it was 25 State Chapter / Union Territory Committees would be renominated for a period of ONE year from the date issue of this letter. The SCCs / UTCs will be given a guideline to achieve specific targets during this period with IYA SCORE CARDS FOR STATES (Enclosure 1) The 25 SCCs / UTCs that have been resolved till the 39th Executive Council Meeting of the Association held on 11 January 2024.
- 2. As per the resolution in the 27th Meeting of the Executive Council, that the revenue share for memberships generated by the Center would be 30:70 to the States for all memberships referred by the Center and the memberships generated by the States would be shared 70:30 to the States.
- 3. Central Coordinators will be nominated for the SCCs. The travel, boarding and lodging is to be borne from the State funds. Please facilitate regular inspection of your State Chapter Committee office. The inspection will involve Physical office location, Ensure IYA banners in place, Bank account verification, Financial record keeping, Meeting all the individual members of the State at a common gathering / event, Visit the institutional members of the State, etc
- 4. The State representatives should attend Central Committee meetings
- 5. The States should actively promote and participate in National-level projects, Yogavani, Online Gurukulam, IYA events, etc
